The Ghanaian state has been captured by the mining power elites something that allows them to undertake criminal and destructive mining with impunity These state captors are not doing artisanal and small scale mining ASM but rather capitalist mechanized mining CMM which ravages the environment on a large scale and with breakneck speed State capture in Ghana's ASGM sector is demonstrated clearly in the book through vivid description and rigorous analysis of the failed militarised fight against the galamsey menace between 2017 and 2022 This is the period the Head of State and Commander in Chief of the Ghana Armed Forces GAF vowed to fight and defeat the perpetrators of this crime at the risk of losing his presidency.
