"That by Him, and through Him, and of Him, the worlds are and were created, and the immortals thereof are begotten sons and daughters unto God" (D&C 109:2-5).

We declare in words of eternity that His priesthood and His Church have been restored upon the earth—"Built upon the foundation of . . . apostles and prophets, Jesus Christ himself being the chief corner stone" (Ephesians 2:20).

We bear testimony, as His duly ordained Apostles—that Jesus is the Living Christ, the eternal Son of God. He is the great King Immortal who stands before us on the right hand of His Father. He is the Light, the life, and the hope of the world. He was the one that made it possible for this life and opened His way to the world to come. We will be thankful for the matchless gift of His divine Son.
